- 3. All BSNLI/MTNL PSTN, subscribers may make calls:
- Televoting with charge means call charges will be borne by calling party. Televoting Free means call charges will be borne by the Televote subscriber and not by calling party.
- All voters will be given announcement, "Thank you for your vote. However nth caller (winner) will be given special announcement. "You are winner but we are not able to connect you to operator".
- Before the voting window, "It is too early voting has not yet started" List of announcement in case of different situations in Televoting are as follows.
